- 7) Ensure the effective integration of social safeguards and due diligence as defined in the ESMP (Environment & Social Management Plan) & ESIA while designing, implementation and monitoring of water supply & sanitation schemes as well as to take due cognizance of disclosure requirements.
- 8) Prepare TORs to guide contractors to prepare site specific social safeguards instruments required for mitigating social impacts of proposed projects prior to commencement of civil works;
- 9) Screening of DWSS sub-projects and advising requirement of specific management and action plans to mitigate adverse social impacts due to various project interventions
- 10) Ensure zero tolerance for sexual exploitation and abuse by project workers (including the contractors and implementing agency staff, facilitate HIV/AIDs orientation programme at construction sites, address any issue related to labour influx in consultation with Labour Officer of the project etc.
- 11) Identify the capacity building needs of DWSS staff especially with the IEC & CDS, NGOs and technical staff engaged in the project for achieving sustainability of the project and capacitate them through trainings.
